Gift Aid 2016/2017 Parents Annual Voluntary Maintenance Contributions

All Saints is a Voluntary Aided Church School, as such the Governors are responsible for paying 10% of the cost of the school's capital projects. This is all detailed in our prospectus which can be viewed on the website.

The Governors and staff at All Saints Carshalton are continually looking at ways to develop and improve the school and we are proud of the welcoming and stimulating learning environment that we provide for our children.
